Research Leads to Advances that Impact Patients

In 1941, the first President of the American Diabetes Association, Dr. Cecil Striker, outlined the purpose of our organization. Dr. Striker said, "The patient suffering from the syndrome of diabetes mellitus is the reason for the existence of the Association." Today, our focus remains the same, on people living with diabetes.

Research is an important component for how the Association enables large scale changes that improve outcomes for people living with diabetes. To this end, the more than 40-year partnership between the Order of the Amaranth and the American Diabetes Association through our Research Foundation has enabled research advances and helped accelerate the careers of some of today's leaders in diabetes research. The result is progress towards better strategies for prevention, treatment, and ultimately a cure for diabetes.

Last year, we saw several major advances take place that will have an immediate impact for people living with diabetes. This includes a new way to treat diabetic kidney disease with an existing medication, a novel formulation to reduce the need for injections in type 2 diabetes, and a trial demonstrating the ability to significantly delay the onset of type 1 diabetes in high-risk individuals. By supporting foundational projects and the scientists that conduct them, our philanthropic supporters, including the Order of the Amaranth, help to make these major advances possible.

Today, scientists have unprecedented tools and technologies at their disposal. However, diabetes research is also critically underfunded, meaning progress could be greatly accelerated if funding matched the scope of the epidemic. That's why the fundraising efforts each year through the Amaranth Diabetes Foundation is critical.

Together, we can accomplish the American Diabetes Association mission: to prevent and cure diabetes and to improve the lives of all people affected by diabetes. We thank you for your continued support of diabetes research and look forward to an exciting year filled with new discoveries.

In the meantime, some exciting things have been happening with the ADF Board of Directors:

- In March we selected a new three-year Research Grant. The recipient is Dr. Nikki Farnsworth from Colorado School of Mines. Dr. Farnsworth project overview: Though we can identify individuals at high-risk for developing type 1 diabetes (T1D) there is currently no way to prevent it or restore function of insulin-producing beta cells. Dr. Farnsworth will study a process within beta-cells that she believes causes their death in response to an immune attack. Her research could lead to new ways to prevent or restore the function of beta-cells in people at risk or with T1D, respectively.
- Amaranth Diabetes Foundation, Inc now has a Facebook page. Please check this out and make comments. In July the Board will discuss some guidelines for the page but I believe this could be a good way to let people know what you are doing in your jurisdictions.

In just a few months we will be celebrating the hard work that each of you has put forth this past year as we will learn the donation amount to the American Diabetes Research Foundation. I want to thank you for everything that you are doing.

Before the pattern and directions could be sent out by email, they were approached by H.L. Rhonda Rallios of Loyalty Court, who works for a company which produces food. Her company was in desperate need to provide 1500 masks for their employees. The company approached us with the idea that they wanted to give back by making a substantial donation to Diabetes Research.

1500! This was not a project for one or two people. The call went out for help, and the supplies began to be gathered. Even members who don't sew can help. Some are cutting fabric. Others are cutting pipe cleaners in half (used in the top of the mask to form a seal over the nose). Members up and down the state are sewing like mad. As of this writing, less than a week from the request, the first 55 masks were delivered with many more to be made and delivered within the next few days. We will let you know the outcome of this project in the next edition of *The Crown and Sword*.


