# AMARANTH DIABETES FOUNDATION BOARD OF DIRECTORS H.L. JANET ST. JACQUES, ADF President

It was great being able to come together for the 124<sup>th</sup> Supreme Council Assembly, "Dreams Come True" Session, in Tulsa, Oklahoma.

It was very exciting for the ADF board and all our members when H.L. Charlene Tucker announced the donation to American Diabetes Association in the amount of \$481,800.15. Our donation this year represents the dedication and hard work of each of the members of the Order of the Amaranth.

The ADF is currently funding two scientists: Judith Agudo, PhD, harnessing immune privilege mechanisms from stem cells to protect beta-cells from immune attack and Jun Zou, PhD, Protection against dysglycemia via fiber-mediated nourishment of gut microbiota. In addition, Dr. Laura Alonso has asked for an extension to finish her research on Regenerating beta cells to treat and prevent diabetes with no funds being given.

Many of the Subordinate and Grand Courts were still unable to meet but by their dedication of thinking outside the box made the successful fund raising for the support for Diabetes Research.

The top Grand Courts in 2022 were: Pennsylvania \$75,997.01, Georgia \$48,907.57, Oregon \$24,296.19, Arizona \$22,994.03 and California \$17,505.00. Although we did not have any Milestones reached this year, many Grand Courts are so close to their next Milestone.
