





AMERICAN DIABETES ASSOCIATION Susan Dishart Amaranth Liaison

It is a busy time of year, and the American Diabetes Association®(ADA) is SO thankful to all of you for your great work in raising funds and sharing the message about the importance of diabetes research. It has been wonderful to travel to several Grand Courts already and I look forward to seeing many of you throughout the rest of the season. In March, members of the Amaranth Diabetes Foundation board were able to join me to meet Dr. Baker and Dr. Chang at Yale University. Your work to raise funds to support research are making a difference and the researchers THANK YOU as well as the millions living with diabetes.

I wanted to share some updates from the ADA as there are new recommendations on nutrition, weight-loss medications and technology. The American Diabetes Association® (ADA) released <u>Standards of Care in Diabetes 2025</u> (Standards of Care) the gold standard in evidence-based guidelines for diagnosing and managing diabetes and prediabetes. Based on the latest scientific research and clinical trials, the *Standards of Care* includes strategies for diagnosing and treating diabetes in both youth and adults, methods to prevent or delay type 2 diabetes and its associated comorbidities like obesity, and care recommendations to enhance health outcomes.

Notable updates to the *<u>Standards of Care in Diabetes - 2025</u>* include:

- Consideration of continuous glucose monitor (CGM) use for adults with type 2 diabetes on glucose-lowering agents other than insulin.
- Guidance on actions to take during circumstances of medication unavailability, such as medication shortages.
- Additional guidance on the use of GLP-1 receptor agonists beyond weight loss for heart and kidney health benefits.
- Guidance on continuation of weight management pharmacotherapy beyond reaching weight loss goals.
- Expanded nutrition guidance to encourage evidence-based eating patterns, including those incorporating plant-based proteins and fiber, that keep nutrient quality, total calories, and metabolic goals in mind.

The ADA annually updates its *Standards of Care* through the efforts of its Professional Practice Committee (PPC). Comprising global experts from diverse professional backgrounds, the PPC includes physicians, nurse practitioners, certified diabetes care and education specialists, registered dietitian nutritionists, pharmacists, and methodologists. Its members hold expertise in a range of related fields.

"Improving the lives of people affected by diabetes is a key part of the ADA's mission. The *Standards of Care* offers the trusted support needed for people living with diabetes and those caring for them to manage the disease and thrive until we find a cure," said Chuck Henderson, CEO at the American Diabetes Association. AMARANTH DIABETES FOUNDATION BOARD OF DIRECTORS H.L. Charlene Tucker, President

The past couple of months have been busy with the ADF Board of Directors. The American Diabetes Association presented six research projects as options for support by the ADF. Each opportunity aligned with our request prioritizing research for a cure or to reduce or eliminate complications. In addition, each innovative project option aligned with our commitment to fund the strongest science, and the most pioneering ideas poised to tackle the mysteries of diabetes. Dr. Ilia Droujinine from the Scripps Research Institute and Dr. Giorgia Zanetti from Columbia University have been chosen as our two newest Research Grants. Both researchers will be funded along with Dr. Judith Agudo, Dana Farber Cancer Institute, Dr. Megan Baker, Yale University, and Dr. Lisa Beutler, Northwestern University Medical Center.



Ilia Droujinine, PhD - The Scripps Research Institute

Decoding and validating interorgan communication proteins as new therapeutic targets in diabetes

Organs produce secreted proteins that travel to other organs as a means of communication, and this communication becomes faulty in diabetes. This project will use this technology to identify and characterize novel secreted proteins involved in organ-to-organ communication in diabetes. Most importantly, is to advance our research to the translational, preclinical stage, because the identified secreted proteins may become new diagnostic biomarkers and therapeutics to treat the underlying causes of prediabetes and diabetes. This will further characterize these proteins, both helping to validate the technology as a platform that can enable more future discoveries, as well as evaluating their potential to serve as therapy for diabetic prevention or treatment in the future. *(Grant funded through December 31, 2029)*



Giorgia Zanetti, PhD - Columbia University

Developing a novel T1D mouse model to understand the interactions between human autoimmune systems and human T cells

Type 1 diabetes (T1D) is caused by immune destruction of insulinproducing beta-cells. This research will help predict how different

patients might respond to the drug and identify markers for success or resistance, paving the way for personalized T1D treatments. A humanized mouse model will be generated with human immune systems. These mice will develop diabetes by T cell recognition of antigens presented by human beta-cells. This research could lead to treatments that might help protect these cells in people with T1D, reducing their need for insulin injections and potentially slowing down or even preventing the disease.

(Grant funded through December 31, 2027)

Activated in 2001, 2011, and now 2024, AIDNET is supporting currently disaster recoverv stemming from the aftermath of Hurricane Helene. They are helping the citizens of Greene County, Tennessee, repair and/or rebuild their homes and lives at no charge to them. AIDNET has assisted approximately 60 families recover from the devastation of Hurricane Helene and is still working hard to get the citizens of the community affected by the flooding.

A group of contractors and individuals saw a need in August of 2001 for a nonprofit organization to help people repair and/or rebuild after a flash flood hit the Greene County area. AIDNET was founded due to the flooding. The second time AIDNET was activated was in April 2011 during the Super Tornado outbreak that hit the area.

Much of the money to help with the repairing and rebuilding is raised by local groups, clubs, businesses and individuals. In January, AIDNET received a grant of \$100,000 from the East Tennessee Foundation, a philanthropic organization based in Knoxville, Tennessee.

ADF Board of Directors' Visit to Yale University Charlene Tucker, DSRM President, ADF Board of Directors

Many members from the Amaranth Diabetes Foundation Board of Directors, along with Susan Dishart, Planned Giving Officer and Chelsy Olsen, Planned Giving Manager from the American Diabetes Association, visited two of our research grant recipients at Yale University on Thursday, March 27, 2025. The board heard presentations about research grants we are funding along with a tour of the labs of Megan Baker, MD and William Chang, PhD. Both researchers expressed their appreciation and gratitude for the support that the Order of the Amaranth has given them.

Megan Baker's project focuses on investigating the progression of diabetic kidney disease, aiming to unravel the mechanisms leading to kidney failure. The goal is to develop treatments that specifically target these identified pathways, thereby altering the natural course of the disease. Ultimately, this project holds the potential to contribute significantly towards the prevention and treatment of diabetic kidney disease by offering insights into novel therapeutic targets. (Grant funded through June 30, 2027)

William Chang - Diabetes results in hyperglycemia that damages micro vessels throughout the body. This is known as diabetic microangiopathy and can lead to dysfunction of multiple organs including the brain, eyes, heart, kidneys and nerves. This study will increase the understanding of the biological processes driving diabetes-related small vessel disease, generate new biomarkers to track disease, and establish a platform to potentially test new therapeutics. (Grant funded through June 30, 2025)


