

2027 Trip to the Philippines and the 50th Annual Session of the Grand Court of the Philippines

Experience the history, culture, architectural treasures and the rich natural resources of Manila and its neighboring areas:

- Sunset cruise in Subic Bay, you’ll be treated to a complimentary dinner while you relax on the yacht and witness the stunning view and sunset.
- Step back in time during the Spanish colonial era, explore the historic Walled City of Intramuros, and Fort Santiago; this is a half day tour after which we explore the Mall of Asia, the largest Mall in the country, a must-see destination for shopping, dining and entertainment. We will then proceed to a top-rated Viking Buffet Restaurant for dinner where you will enjoy the varieties of international cuisines including seafoods and authentic Filipino food.

To join the tour, you should arrive in Manila on April 26, 2027. The tour date will be April 27 – May 1, 2027. Grand Court session is May 2-4, 2027.

Cost is \$1,950 per person based on double occupancy (hotel). This includes meals during tours, transportation and hotel accommodations from April 26 – May 5, 2027. Airfare not included. Deposit of \$500 is required to reserve your spot on or before January 31, 2027, and will be credited towards your total cost.**

Final balance is due in cash upon arrival in Manila on April 26, 2027.

Grand Court Session Registration is not included in the package cost and usually totals about \$80 per person. You should arrange for your own session registration when the Grand Court invitation is available. Grand Court Session Registration covers your meals during Grand Court.

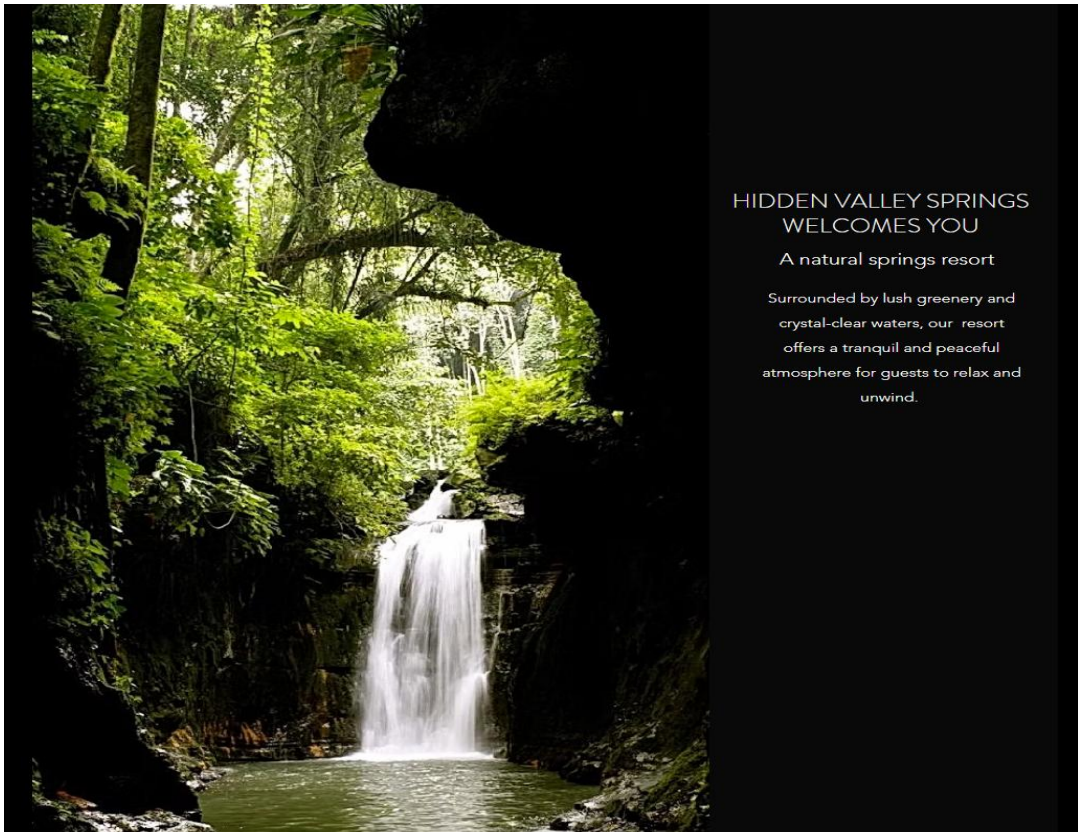
